



**FDOT Broward County Traffic Report
April 27 through May 4, 2018**

FORT LAUDERDALE -- Construction and maintenance-related lane closures on state highways in Broward County are expected during the week of April 27 through May 4, 2018. Weather permitting, work will be done at the following locations throughout the county.

INTERSTATE CONSTRUCTION PROJECTS

Interstate 95

**1. South of Broward Boulevard to north of Commercial Boulevard in Fort Lauderdale
Traffic Impact:**

- Three northbound and southbound lanes of I-95 will be closed Sunday through Thursday night between 10:30 p.m. and 5:00 a.m. The first lane will close at 10:30 p.m., the second lane at 11:30 p.m. and the third lane at 12:30 a.m. until 5:00 a.m. All lanes will be open by 5:30 a.m.
- I-95 in both directions, from south of Davie Boulevard to north of Commercial Boulevard, will have intermittent shoulder and ramp shoulder closures, as needed, daily and nightly.
- The I-95 northbound exit ramp to Commercial Boulevard will have one left lane closed, daily, 9:00 a.m. until 3:00 p.m., Monday through Friday, through May.
- The I-95 northbound entrance ramp from Oakland Park Boulevard will undergo a full nightly closure, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will detour via Commercial Boulevard and Powerline Road. FHP will be on scene to assist motorists.
- The I-95 northbound exit ramps to Oakland Park Boulevard will be closed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will detour via Commercial Boulevard. FHP will be on scene to assist motorists.
- The I-95 southbound exit ramp to Oakland Park Boulevard will be closed, as needed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will be detour via I-95 and Sunrise Boulevard. FHP will be on scene to assist motorists.

- The I-95 southbound entrance ramps from Oakland Park Boulevard will be closed, as needed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will detour via Powerline Road and Sunrise Boulevard. FHP will be on scene to assist motorists.
- The I-95 southbound exit ramp to Sunrise Boulevard will be closed, as needed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will detour via Broward Boulevard and I-95. FHP will be on scene to assist motorists.
- The I-95 southbound entrance ramps from Sunrise Boulevard will be closed, as needed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday. Traffic will detour via Powerline Road, Oakland Park Boulevard and I-95. FHP will be on scene to assist motorists.
- The I-95 southbound exit ramp to Broward Boulevard will be closed, 11:30 p.m. until 5:00 a.m., Sunday through Thursday night, through May. Traffic will detour via I-95 and SR 84/Marina Mile. FHP will be on scene to assist motorists.

Description: This project will extend the High Occupancy Toll lanes from north of Commercial Boulevard to south of SW 10th Street in Broward County. The scope of work includes adding a lane and converting the High Occupancy Vehicle (HOV) lanes to create two express lanes in each direction. Other work includes: installing Intelligent Transportation System (ITS) and tolling equipment; widening bridges; and installing noise barrier walls at locations along I-95 northbound between Atlantic Boulevard and Sample Road, and along I-95 southbound north of Sample Road. Contract time for this \$154 million project began Friday, January 8, 2016, with design activities currently underway. Construction began Sunday, August 14, 2016. Cost/Completion: Construction cost is \$154 million. Completion is expected in spring 2020.

2. I-95 from north of Commercial Boulevard in Fort Lauderdale to south of SW 10th Street in Deerfield Beach

Traffic Impact:

- Three northbound and southbound lanes of I-95 between Commercial Boulevard and SW 10th Street will be closed Sunday through Thursday night between 10:30 p.m. and 5:30 a.m. The first lane will close at 10:30 p.m., the second lane at 11:30 p.m. and the third lane at 12:30 a.m. until 5:30 a.m.
- One lane in each direction of Atlantic Boulevard from Andrews Avenue to N. Dixie Highway will be closed daily, 9:00 a.m. until 3:00 p.m., Monday through Friday.
- One lane in each direction of Copans Road between North Andrews Avenue and North Dixie Highway will be closed daily, 9:00 a.m. until 3:00 p.m., Monday through Friday.
- McNab Road at I-95 will have two lanes closed in each direction, Sunday through Thursday night between 10:30 p.m. and 5:00 a.m.
- The I-95 southbound entrance ramp from Andrews Avenue will be closed nightly, 10:00 p.m. until 5:00 a.m., Sunday night through Thursday. Traffic will detour via Commercial Boulevard. FHP will be on scene to assist motorists.
- McNab Road at I-95 will be closed for bridge construction, 11:00 p.m. until 5:00 a.m., Sunday through Thursday. Eastbound traffic will detour via N. Andrews Avenue, Cypress Creek Road and S. Dixie Highway. Westbound traffic will detour via S. Dixie Highway, Cypress Creek Road, and N. Andrews Avenue. FHP will be on scene to assist motorists.
- Sample Road at I-95 will be closed for bridge construction, 11:00 p.m. until 5:00 a.m., Sunday through Thursday. Eastbound Sample Road traffic will detour via I-95 and Copans

Road. Westbound Sample Road traffic will detour via I-95 and SW 10th Street. FHP will be on scene to assist motorists.

- Atlantic Boulevard at I-95 will be closed for bridge construction, 11:00 p.m. until 5:00 a.m., Sunday through Thursday. Eastbound Atlantic Boulevard traffic will detour via I-95 southbound and Cypress Creek Road. Westbound Atlantic Boulevard traffic will detour via I-95 northbound and Copans Road. FHP will be on scene to assist motorists.
- **Long-term Full Closure Notice:** The Park & Ride entrance from the eastbound exit ramp to Cypress Creek Road is closed completely, reopening 5:00 a.m., Friday morning, May 11. Traffic will detour east along Cypress Creek Road to a U-Turn at NE 7th Ave/Corporate Drive, and then west along Cypress Creek Road to the Park and Ride.
- **Long-term Full Closure Notice:** The I-95 southbound entrance ramp from the Cypress Creek Park & Ride Lot is closed completely, reopening 5:00 a.m., Thursday morning, May 31. Traffic will detour via West Cypress Creek Road or North Andrews Avenue and I-95. FHP will on scene to assist motorists.

Description: This project will extend the High Occupancy Toll lanes from north of Commercial Boulevard to south of SW 10th Street in Broward County. The scope of work includes adding a lane and converting the High Occupancy Vehicle (HOV) lanes to create two express lanes in each direction. Other work includes: installing Intelligent Transportation System (ITS) and tolling equipment; widening bridges; and installing noise barrier walls at locations along I-95 northbound between Atlantic Boulevard and Sample Road, and along I-95 southbound north of Sample Road. Contract time for this \$154 million project began Friday, January 8, 2016, with design activities currently underway. Construction began Sunday, August 14, 2016. 3. I-95 Interchange from Hillsboro Boulevard to SW 10th Street

Traffic Impact:

- The I-95 southbound exit ramp to SW 10th Street will be fully closed, as needed, Sunday night through Thursday night between 9:00 p.m. and 5:00 a.m. Motorists can detour via Hillsboro Boulevard.
- The outside lanes of I-95 southbound from Hillsboro Boulevard to SW 10th Street will be closed Sunday night through Thursday night with the first lane closing at 9:00 p.m., the second lane closing at 10:00 p.m. and the third lane, if necessary, closing at 12:30 a.m. until 5:00 a.m.
- Two westbound lanes of SW 10th Street at I-95 will be closed Sunday night through Thursday night between 9:00 p.m. and 5:00 a.m.
- The sidewalk on the north side of SW 10th Street between SW 12th Avenue and SW Natura Boulevard is closed through May 2018. Signs are in place to direct pedestrians to the south sidewalk.

Description: Construction on this 1.5-mile project began Monday, January 26, 2015. Work consists of widening southbound I-95 to add an auxiliary lane from the Hillsboro Boulevard entrance ramp to the SW 10th Street exit ramp, widening the existing southbound I-95 exit ramp to SW 10th Street, addition of a free flow right turn lane to westbound SW 10th Street, widening of westbound SW 10th Street to add an acceleration lane, utility relocation, milling and resurfacing, bridge widening, installation of barrier walls, curbs, sidewalks, guardrail, drainage, overhead signs, signing and pavement markings, signals, lighting, and retaining walls. This is the

Cost/Completion: Construction cost for all five projects is \$32.5 million. Completion in spring 2018.

4. I-95 from south of SW 10th Street to south of Glades Road

Traffic Impact:

- I-95 will have two inside lanes closed in each direction nightly, as needed, between Hillsboro Boulevard and Camino Real, with the first lane closing at 9:30 p.m. and the second lane closing at 10:30 p.m., until 5:30 a.m., Sunday through Thursday, through May. Description: This 4.8-mile project will extend the High Occupancy Toll lanes from south of SW 10th Street to south of Glades Road in Broward and Palm Beach counties. The scope of work includes widening and converting the existing I-95 HOV Lanes to Managed Lanes which will result in two tolled Express Lanes in each direction; the number of General Use lanes will remain the same. Other activities include reconstruction of I-95 on the northbound and southbound approaches to the Hillsboro Canal bridges, milling and resurfacing of I-95, construction of northbound and southbound auxiliary lanes between Hillsboro Boulevard and Palmetto Park Road, and construction of a northbound auxiliary lane between the SW 10th Street entrance ramp and the Hillsboro Boulevard exit ramp. Other project improvements include: guardrail, barrier wall, attenuators, shoulder gutters, drainage, dredging of Hillsboro Canal, bridge widenings at Palmetto Park Road and Camino Real, bridge replacement at Hillsboro Canal, temporary and permanent retaining walls, noise wall construction, sign structures, portable traffic monitoring sites, toll gantry installation, Intelligent Transportation System (ITS) installation, signing and pavement markings; Express Lane markers, lighting, ramp metering signals, utility relocation, and landscape relocation. Contract time for this \$102 million project began Monday, July 10, 2017, with design and construction activities currently underway. Cost/Completion: Construction began Monday, January 8, 2018. Work is being performed by Prince Contracting, LLC and is expected to be completed spring 2022.

Interstate 75

5. Segments A & B - I-75 from NW 170 to South of Miramar Parkway

- Two lanes in each direction of I-75 from Miami Gardens Drive to NW 170 Street will be closed nightly Sunday, April 29 through Thursday, May 3. The northbound lane will be closed from 9:00 p.m. to 6:00 a.m., and the southbound lane will be closed from 10:00 p.m. to 6:00 a.m.
- Two southbound lanes of I-75 from Florida's Turnpike to Miami Gardens Drive will be closed nightly Sunday, April 29 through Thursday, May 3 from 9:00 p.m. to 6:00 a.m.
- Two lanes in each direction of I-75 from Miramar Parkway to Florida's Turnpike will be closed nightly Sunday, April 29 through Thursday, May 3. The northbound lanes will be

closed from 10:00 p.m. to 6:00 a.m., and the southbound lanes will from 9:00 p.m. to 6:00 a.m.

- Two northbound lanes of I-75 from NW 170 Street to Miami Gardens Drive will be closed nightly Sunday, April 29 through Thursday, May 3 from 10:00 p.m. to 7:00 a.m.
- One lane in each direction of Florida's Turnpike from Red Road to the I-75 Interchange will be closed nightly Sunday, April 29 through Thursday, May 3 from 10:00 p.m. to 6:00 a.m.
- One lane in each direction of Florida's Turnpike from I-75 Interchange to Okeechobee Road will be closed nightly Sunday, April 29 through Thursday, May 3 from 10:00 p.m. to 6:00 a.m.
- One northbound ramp lane of Florida's Turnpike from Okeechobee Road to I-75 Interchange will be closed nightly Sunday, April 29 through Thursday, May 3 from 10:00 p.m. to 6:00 a.m.
- One southbound ramp lane of I-75 from Snake Creek Canal to Florida's Turnpike will be closed nightly Sunday, April 29 through Thursday, May 3 from 9:00 p.m. to 6:00 a.m.
- One lane in each direction of I-75 from NW 170 Street to Florida's Turnpike will be closed daily Sunday, April 29 through Thursday, May 3 from 10:00 a.m. to 4:00 p.m.
- One northbound ramp lane of I-75 from Florida's Turnpike will be closed Saturday, April 21, from 9:00 a.m. to 3:00 p.m.
- The northbound ramp to I-75 from Florida's Turnpike will be closed 11:00 p.m. Wednesday, May 2 to 5:00 a.m. Thursday, May 3. During this time, motorists wishing to use the northbound ramp to I-75 from Florida's Turnpike will be detoured to exit at US 27/Okeechobee Road (Exit 35), continue south on US 27/Okeechobee Road to NW 138th Street, and east on NW 138th Street to Hialeah Garden Boulevard to take the northbound entrance ramp to I-75.
- All northbound lanes on I-75 between Florida's Turnpike and Bass Creek Bridge will be closed 11:00 p.m. Wednesday, May 2 to 5:00 a.m. Thursday, May 3. During this time, motorists wishing to travel northbound on I-75 between Florida's Turnpike and Bass Creek Bridge will be detoured to exit at Miami Gardens Drive (Exit 4), continue east on Miami Gardens Drive to Flamingo Road, north on Flamingo Road to Miramar Parkway, and west on Miramar Parkway to take the northbound entrance ramp to I-75.

6. Segment C - I-75 from South of Miramar Parkway to South of Sheridan Street in Broward County

- One westbound lane of Miramar Parkway will be closed from 11:00 p.m. Monday, April 30 to 3:00 a.m. Tuesday, May 1. A 15-minute full closure will also occur during that time frame in order to allow crews to perform the work safely. If necessary to complete the work, this lane closure will also take place from 11:00 p.m. Tuesday, May 1 to 3:00 a.m. Wednesday, May 2.

7. Segment D - I-75 from South of Sheridan Street to North of Griffin Road

- One eastbound and one westbound lane of Sheridan Street may be closed Sunday, April 29 through Thursday, May 3 from 9:00 a.m. to 6:00 p.m. as the contractor continues to work in this area.

- Two eastbound or two westbound lanes of Sheridan Street may be closed Sunday, April 29 through Thursday, May 3 from 10:00 p.m. to 5:00 a.m. as the contractor continues to work in this area.

8. Segment E - I-75 from North of Griffin Road to I-595 in Broward County

- All lanes are open.

9. The northbound ramp to I-75 from Florida's Turnpike will be closed 11:00 p.m.

During this time, motorists wishing to use the northbound ramp to I-75 from Florida's Turnpike will be detoured to exit at US 27/Okeechobee Road (Exit 35), continue south on US 27/Okeechobee Road to NW 138th Street, and east on NW 138th Street to Hialeah Garden Boulevard to take the northbound entrance ramp to I-75.

13. All Northbound Lanes on I-75 between Florida's Turnpike and Bass Creek Bridge Scheduled to Close Wednesday, May 2:

All northbound lanes on I-75 between Florida's Turnpike and Bass Creek Bridge will be closed 11 p.m. Wednesday, May 2 to 5 a.m. Thursday, May 3. **During** this time, motorists wishing to travel northbound on I-75 between Florida's Turnpike and Bass Creek Bridge will be detoured to exit at Miami Gardens Drive (Exit 4), continue east on Miami Gardens Drive to Flamingo Road,

north on Flamingo Road to Miramar Parkway, and west on Miramar Parkway to take the northbound entrance ramp to I-75.

Interstate 595

14. One lane on I 595 Westbound on west side of Flamingo Bridge:

One lane on I 595 Westbound on west side of Flamingo Bridge will be closed from 9:00pm to 5:00am/Two lanes on I 595 Westbound on west side of Flamingo Bridge will be closed from 11:00pm to 5:00am on Sunday April 29, 2018 and Monday, April 30, 2018 for Milling and resurfacing.

15. One Lane on I 595 Eastbound on east and west side of University Bridge:

One Lane on I 595 Eastbound on east and west side of University Bridge will be closed from 9:00pm to 5:00am/ Three lanes on I 595 Eastbound on east and west side of University Bridge will be closed from 11:00pm to 5:00am on Monday, April 30, 2018 and Tuesday, May 1, 2018 for Milling and resurfacing.

16. One right lane on I-75 Southbound to Eastbound I-595:

One right lane on I-75 Southbound to Eastbound I-595 will be closed from 9:00pm to 5:00am on Tuesday May 1, 2018 until Friday, May 4, 2018 for CMS work.

17. One left lane on I-75 Northbound to Eastbound I-595:

One left lane on I-75 Northbound to Eastbound I-595 will be closed from 9:00pm to 5:00am on Wednesday May 2, 2018 until Friday, May 4, 2018 for CMS work.

18. One right lane on I-75 Northbound to Eastbound I-595:

One right lane on I-75 Northbound to Eastbound I-595 will be closed from 9:00pm to 5:00am on Thursday, May 3, 2018 until Friday, May 4, 2018 for CMS work.

Northeast Broward

19. A1A Improvements Project from Oakland Park Boulevard to Flamingo Avenue in Fort Lauderdale

Traffic Impact:

- **This project was completed Tuesday, April 17.**

Description: Project improvements include removing old asphalt and resurfacing the roadway within the project limits, upgrading sidewalks and ramps to meet ADA requirements, repairing, adjusting, and replacing drainage structures throughout the project limits, upgrading the following existing intersections to mast arm signals: 34th Street, mid-block between 36th and 40th Street, and at 40th Street, upgrading all existing pedestrian signals to countdown timers, upgrading signs and pavement markings throughout the project limits, including adding a 1.5 foot striped buffer to separate the four-foot wide bike lanes from the outside vehicle travel lane, upgrading existing lighting along the corridor to lighting with a variable intensity function that can be accessed remotely in order to cause minimal disruption to sea turtles during their nesting season, adding elevated roadway lighting and lower level lighting to illuminate the sidewalk, and adding a business access drive aisle along the east side of road between NE 34th and NE 36th

Cost/Completion: \$9.3 million / Early 2018

20. Broward Boulevard Improvements and Bridge Replacement Project in Fort Lauderdale

Traffic Impact:

- Up to two lanes in each direction of Broward Boulevard from US 1 to NW 18 Avenue (500 feet maximum at a time) will be closed between 10 p.m. and 6 a.m. and Saturdays between 9 a.m. and 4 p.m. for drainage improvements, widening, curb and gutter installation, and sidewalk construction.
- Portions of the sidewalk on either side of the road from NW 18 Avenue to US 1 are closed for construction. Signs are in place to direct pedestrians to the open sidewalk on the opposite side of the road.
- One westbound lane of Broward Boulevard from NW 15 Avenue to NW 18 Avenue at the approaches to and from the bridge over the North Fork New River may be closed at any time through May for emergency AT&T fiber relocation.

Description: Project improvements include replacing the bridge over the North Fork of the New River, removing old asphalt and resurfacing the roadway, upgrading crosswalk ramps to meet ADA requirements, upgrading signs and pavement markings, relocating bus shelters, adding roadway lighting, installing drainage structures, upgrading signalized intersections to mast arms, reconstructing sidewalks, and widening roadway to add bike lanes in each direction. 21. Hillsboro Boulevard Improvements Project from Military Trail to US 1 in Deerfield Beach

Traffic Impact:

- One lane in each direction of Hillsboro Boulevard from Military Trail to US 1 may be closed for signalization improvements, paving, striping, and miscellaneous construction activities through May.
- Up to two lanes in each direction of Hillsboro Boulevard from Military Trail to US 1 will be closed nightly between 7:30 p.m. and 5:30 a.m. through May for milling and resurfacing.

Description: Project improvements include improving the off-ramp from northbound I-95 to eastbound Hillsboro Boulevard including adding a new signalized intersection and adding second lane to increase capacity, relocating and upgrading drainage structures, upgrading crosswalk ramps to meet ADA requirements, constructing new stamped asphalt crosswalks from east of Natura Boulevard to US 1, upgrading existing pedestrian signals to countdown timers, upgrading signalized intersections to mast arms, installing new decorative lighting, constructing new medians east of SE 2 Avenue, removing old asphalt and resurfacing the roadway, upgrading signs and pavement markings to reflect the new roadway configuration as follows: (1) Military Trail to Dixie Highway - Three 11-foot lanes in each direction (2) NE / SE 2 Avenue to US 1 - Two 11-foot lanes in each direction, and adding a bike lane or sharrows in each direction as follows: (1) Military Trail to NW/SW 2 Terrace - 4-foot bike lane (2) NW / SW 2 Terrace to NE

22. Broward Mobility Project

Traffic Impact:

- One lane on each direction of NW 31 Avenue from Sunrise Boulevard to Oakland Park Boulevard will be closed Monday through Thursday evenings between 8 p.m. and 5 a.m. for milling and resurfacing.
- One lane in each direction of SW 4 Avenue from SW 28 Street to SR 84 will be closed Monday through Friday between 9 a.m. and 4:30 p.m. for roadway widening and median reconstruction.
