

RESOLUTION NO. R-2020-143

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT THE FY2020 CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING GRANT PROGRAM FROM THE U.S. DEPARTMENT OF JUSTICE IN AN APPROXIMATE AMOUNT OF \$129,126.00; FURTHER AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS; AMENDING THE FISCAL YEAR 2020 OPERATING BUDGET (R-2019-283).

WHEREAS, the City of Hollywood has applied for grant funds under the Justice Assistance Program for the Coronavirus Emergency Supplemental Funding Grant Program provided to the U.S. Department of Justice; and

WHEREAS, the Chief of Police recommends the appropriate City officials accept the FY2020 Coronavirus Emergency Supplemental Funding Grant Program funds from the U.S. Department of Justice in an approximate amount of \$129,126.00, in order to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus, and further authorizing appropriate City officials to execute all applicable grant documents and agreements; and

WHEREAS, allowable projects and purchases include but are not limited to overtime, equipment (including law enforcement and medical personal protective equipment), hiring, supplies (such as gloves, masks, sanitizer), training, travel expenses, and addressing the medical needs of inmates in state, local, and tribal prisons, jails, and detention centers; and

WHEREAS, the Resolution seeks to amend the budget as detailed in the attached Exhibit "1", which allocates funds to the Police Grants Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the appropriate City officials to accept the FY2020 Coronavirus Emergency Supplemental Funding Grant funds in an approximate amount of \$129,126.00.

RESOLUTION AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT THE FY2020 CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING GRANT PROGRAM FROM THE U.S. DEPARTMENT OF JUSTICE IN AN APPROXIMATE AMOUNT OF \$129,126.00.

Section 3: That these Amendments to the FY 2020 Operating Budget for the Fiscal Year beginning October 1, 2019 and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments to the Operating Budget of the Police Grants Fund (Fund 113) of the City of Hollywood, Florida, for the Fiscal Year 2020.

Section 4: That it approves and authorizes the appropriate City officials to execute all grant documents and agreements upon receiving the grant funds, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That the Department of Financial Services is authorized to create and establish in the appropriate fund the necessary accounts to recognize the receipt of grant funding, and to appropriate grant related funding as may be required.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
