

RESOLUTION NO. R-2020-033

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION, FEDERAL RAILROAD ADMINISTRATION, TO RECEIVE THE FY 2019 TRESPASSING PILOT GRANT PROGRAM OPERATION FAST TRACK; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT, IF AWARDED, THE GRANT IN AN APPROXIMATE AMOUNT OF \$70,144.00; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS, AND IF AWARDED, AMENDING THE FISCAL YEAR 2020 OPERATING BUDGET. (R-2019-283)

WHEREAS, the Police Department submitted an application to the U.S. Department of Transportation, Federal Railroad Administration, for Trespassing Pilot Grant Program Operation Fast Track; and

WHEREAS, Trespassing Pilot Grant Program Operation Fast Track funds will be approximately \$70,144.00; and

WHEREAS, if awarded, the Hollywood Police Department would utilize the grant funds for rail trespassing enforcement related activities and report those activities and the associated benefits to the Federal Railroad Administration; and

WHEREAS, the Chief of Police recommends that the City Commission authorize the appropriate City officials to accept, if awarded, the FY 2019 Trespassing Pilot Grant Program Operation Fast Track funds from the U.S. Department of Transportation; and

WHEREAS, certain periodic budgetary transfers and appropriations continue to be necessary to ensure prudent financial management during the fiscal year; and

WHEREAS, the Resolution seeks to amend the budget as detailed in the attached Exhibit "1", which allocates funds to the Police Grants Fund, if awarded.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it ratifies the submission of the application for the FY 2019 Trespassing Pilot Grant Program Operation Fast Track funds to the U.S. Department of Transportation.

Section 3: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 4: That it approves and authorizes the appropriate City officials to execute all grant documents and agreements upon receiving the grant funds, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That these Amendments, Adjustments and Transfers of funding to the FY 2020 Operating Budget for the Fiscal Year beginning October 1, 2019 as set forth in detail in the attached Exhibit "1" are approved, adopted and accepted as Amendments to the Operating Budget of the Police Grants Fund (Fund 113) of the City of Hollywood for the Fiscal Year 2020.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
